Library Board Meeting, City of Storm Lake, November 14, 2022, 4:00 p.m.

Present: Board President Mary Kay Hudspeth, Jim Eliason, Sarah Freking, Sue Lyngaas, Barb Wells. Also present, Elizabeth Huff, Library Director and Tom Cullen, Times.

Board President Hudspeth called the meeting to order at 4:00 p.m.

Disclosures by Board Members - None

Agenda – Moved by Board Member Lyngaas to approve November 14 Agenda. Seconded by Board Member Freking. Vote all ayes. Motion carried.

Public Hearing – None

Witter Gallery Report - none

Board President, Agreement Study – Board President Hudspeth was waiting for the answers from City Hall and City Attorney to two questions from last month's meeting, (1) the word, supplant and (2) #6 cancel the agreement. The Board was allowed to ask questions. Board Member Lyngaas asked what recourse the Guild had if they needed more funds for a maintenance project such as flooring and should the Library Board add to the funds to complete the project. Board Member Eliason felt #6 terminating the agreement was harsh and the Guild should be asked for correction. Board Member Eliason felt that paragraph 2 in Background should be a numeral term of agreement however Board Member Wells said it was not a legal item but Background. Since Board Member Eliason had brought up the subject of the Library Board funding the Guild, Board President Hudspeth raised the question to the Board on what line item should be cut for Guild funding. Board Member Freking said funding within the agreement was a difficult issue since both the Guild and Library have limited means. Board President Hudspeth would seek consultation by proper channels.

Approval of Minutes – Moved by Board Member Wells to approve October Minutes. Seconded by Board Member Eliason. Vote all ayes. Motion carried. Moved by Board Member Lyngaas to approve October Special Sessions Minutes. Seconded by Board Member Wells. Vote all ayes. Motion carried.

Director's Report – Board Member Eliason asked about the Book Exchange on the Calendar. The Library Director provides youth books for circulation at the Rembrandt and Linn Grove Public Libraries. The two county libraries provide romance books for circulation at our library. The benefits were ILL and Open Access statistics. The Friends had 3 baskets for the annual membership drive and appeal letters were being sent to the community. The Library Director will be attending FIL-ALA in Guadalajara from November 22 to December 1 with a one-day stopover in Los Angeles.

Approval of Bills – Moved by Board Member Freking to approve November Bills. Seconded by Board Member Lyngaas. Vote all ayes. Motion carried.

Approval of Friends Funds – Moved by Board Member Lyngaas to approve Friends Funds by Credit Card Transactions to be paid to the Friends. Seconded by Board Member Wells. Vote all ayes. Motion carried.

Board Member Lyngaas Report, ILA Conference – Board Member Lyngaas claimed ILA was the most fun and informative of all the conferences she had attended in the past. The main theme was inclusion and allowing as many communities as possible into the library. She attended various workshops such as censorship and intellectual freedom.

Library Board Member Requested Items – none.

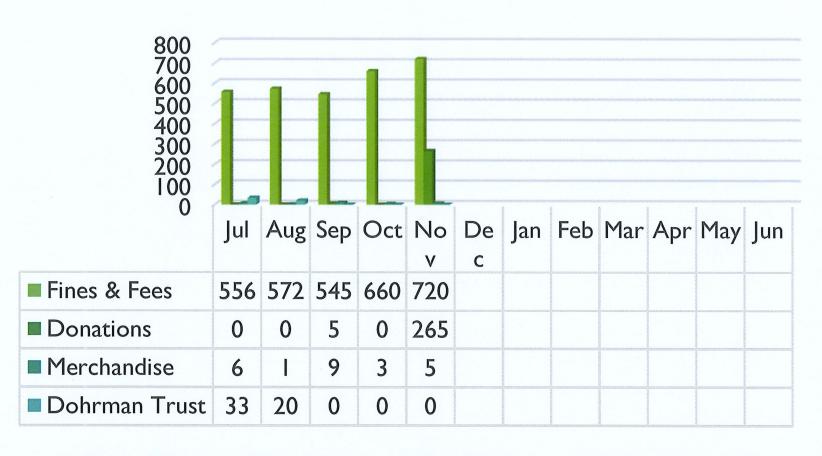
