Library Board Meeting, City of Storm Lake, May 8, 2023, 4:00 p.m.

Present: Board President Mary Kay Hudspeth, Jim Eliason, Sarah Freking, Barb Wells. Also present, Elizabeth Huff, Library Director; Brian Oakleaf, City Finance Director/Library Board Treasurer, Julie Steinfeld, Witter Board President.

Board President Hudspeth called the meeting to order at 4:00 p.m.

Disclosures by Board Members - None

Public Hearing – None

Agenda Approval – Moved by Board Member Wells to approve May 8 Agenda. Seconded by Board Member Freking. Vote all ayes. Motion carried.

Approval of Library Budget FY23-24 – Board Treasurer Oakleaf presented the budget which is consistent with past years and called the Trustees' attention to the highlighted gray area of the current year and next year. He noted the increased revenue from fines. The Library Director said the Front Desk benefited from the increased front desk traffic due to the Colorize closure and limited Hy-Vee service. Payroll and Special Levy made up most of the budget. There will be a 3% increase for salaries. The Board President and Board Member Eliason asked about Contractual Service; examples were given such as Homebound Delivery mileage and Julius Cleaners' rug service. Moved by Board Member Freking to approve Library Budget FY23-24. Seconded by Board Member Eliason. Vote all ayes. Motion carried.

Witter Gallery Report – Witter Board President submitted the Gallery's summer schedule. She brought up the subject of joint programming with Maria Roland and was asked by the Library Director to submit a program idea which will determine the date. Gallery wants the Music Department and Mr. Corbet to perform for the Harmony Gardens opening in August.

Agreement Study – Board President Hudspeth read a response from the City Manager about work sessions, the public invited, action on an agreement, vote by the Trustees and submitting to Council. Board Member Eliason wanted a new draft by all three entities (Gallery, Library and City) to work on an agreement draft, especially on the comingling of funds clause and to add arbitration if the Gallery misuses funds. Board Member Freking objected to voting if the City Attorney has not reviewed the agreement. Board President Hudspeth reminded the Trustees that Council was the final authority. She will consult with the City Manager.

Approval of Minutes – Moved by Board Member Wells to approve April Minutes. Seconded by Board Member Freking. Vote all ayes. Motion carried.

Director's Report – Board Member Eliason asked about abbreviations in Calendar, Library Director said FOL were the Friends. DECAT was DHS Social Worker Group in Orange City. DECAT awards mini-grants which the Library Director applies for on behalf of the Friends for the Summer Reading Program. This year the mini-grant was for Social Worker stipends who can address family concerns during the summer for walk-in patrons. The RTU (HVAC)

was delivered May 2 and workers have been in the mezzanine. Mr. Rebnord will install technology in the Telehealth Room when certain pieces arrive. Board Member Eliason asked about a second computer for proctoring and was told it was essential to have 2 computers in case the Telehealth computer went offline. The Friends approve \$515 for the summer reading program. The Friends' new furniture is being held at Office Elements and rug at Loews until the construction is over and the rooms have been cleaned. The Trustees received an article on censorship. The Director will have a 1-week vacation at the end of May.

Approval of Bills – Moved by Board Member Eliason to approve May Bills. Seconded by Board Member Freking. Vote all ayes. Motion carried.

Work Session on August Board Meeting Date Change – The Library Board will meet on August 7, 2023, since the Library Director will be attending her 50th High School Reunion on August 14, 2023. The Board will adjourn before the start of the City Council Meeting.

Library Board Member Requested Items - none.

Trustees Continuing Education – The Trustees did not have their Continuing Education session due to the long meeting

Adjournment - Moved by Board Member Wells to adjourn the meeting at 5:04 pm. Seconded by Board Member Freking. Vote all ayes. Motion carried.
